- I WAIVE ANY AND ALL CLAIMS that I have or may in the future have against this rental shop.
- I RELEASE this rental shop from any and all liability for any loss, damage, injury or expense that I may suffer, or that my next of kin may suffer, as a result of my use of the equipment described in this Agreement, due to any cause whatsoever, including negligence or breach of contract regarding the design, manufacture, selection, installation, maintenance or adjustment of the equipment.
- I hereby agree to accept the terms and conditions of this contract. This document constitutes the final and entire agreement between this shop and the undersigned. This shop, itself, provides NO WARRANTIES, express or implied, and this snowboarding equipment is accepted "as is".
